Re: RMT Landscape Contractors, Inc. – Contractor License No. 372869

This is to inform you that RMT Landscape Contractors, Inc. (“RMT Landscape”) contractor license number 372869 is suspended for failure to comply with an outstanding civil judgment. The license cannot be reinstated unless the employer has a written payment plan agreement in place or pay of the judgment, in full.

For your reference, attached is a copy of the notice from the California Contractors State License Board (“CSLB”) to RMT Landscape dated May 12, 2025, advising of the license suspension. Additionally, on October 13, 2025, the Northern California Laborers Trust Funds filed a civil lawsuit against RMT Landscape in the United States District Court – Northern District Court of California to recover unpaid trust fund contributions. That litigation is currently pending. See, USDC case number 4:25-cv-08748-KAW.

Based on the above, we request that you review the status of the RMT Landscape contractor license and take all appropriate action to ensure it is in compliance with the law.
