This is a summary of the annual report for Laborers Health & Welfare Trust Fund for Northern California, EIN 94-1235152, for the year beginning June 1, 2015 and ending May 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

SELF-FUNDED BENEFIT INFORMATION

The Trust maintains its medical, prescription drugs, disability, death benefits, physical exam, dental and vision benefits under a self-funded program.

INSURANCE INFORMATION

The following brief description of the Trust benefits are provided for general information purposes only. Participants should refer to the Trust document for more complete information.

The Trust maintains alternative medical plans under contracts with Kaiser Foundation Health Plan for standard medical coverage for participants and dependents. Alternative Dental coverage is provided by Delta Care HMO, Newport Dental and United Healthcare. The plan also maintains a contract with Claremont for behavioral health services. The total insurance premiums charged to the Trust for the year ended May 31, 2016 was \$77,184,999.

BASIC FINANCIAL STATEMENT

The value of Trust assets, after subtracting liabilities of the Trust, was \$69,255,582 as of May 31, 2016 compared to \$85,311,085 as of June 1, 2015. During the Trust year the Trust experienced a decrease in its net assets of \$16,055,503. This decrease included unrealized appreciation or depreciation in the value of Trust assets, that is, the difference between the value of the Trust's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Trust had total income of \$274,983,780. This income included employer contributions of \$252,972,404, employee contributions of \$15,692,744, loss on the sale of assets of \$1,344,584, earnings from investments of \$1,405,710, and other income of \$6,257,506.

Trust expenses were \$291,039,283. These expenses included \$16,152,576 in operating expenses, and \$274,886,707 in benefits paid to participants and beneficiaries.

Benefits and eligibility rules will change from time to time. Retiree benefits differ from active employee benefits and also can be changed or eliminated at any time. Be sure to use the most recent plan booklet and to read any special notices about your coverage. Do not rely on outdated information. If you lose your coverage you may be entitled to continue it by making self payments. Consult your booklet or the plan office for details.

This is a summary of the annual report for Laborers Annuity Plan for Northern California, EIN 94-6277608, for the year beginning June 1, 2015 and ending May 31, 2016. The annual report has been filed with the Employee Benefit Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by the Trust. Plan expenses were \$15,127,517. These expenses included \$1,349,641 in administrative expenses and \$13,777,876 in benefits paid to participants and beneficiaries. A total of 70,842 persons were participants in or beneficiaries of the Plan at the end of the Plan year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$381,351,073 as of May 31, 2016 compared to \$347,925,546 as of May 31, 2015. During the Plan year the Plan experienced an increase in its net assets of \$33,425,527. This increase included unrealized appreciation in the value of Plan assets, that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year.

The Plan had total income of \$48,553,044 including employer contributions of \$44,732,277, losses on the sale of the assets of \$621,869, earnings from investments of \$4,371,978 and other income of \$70,658.

BASIC FINANCIAL STATEMENT

The value of Trust liabilities, after subtracting assets of the Trust, was (5,177,485) as of May 31, 2016, compared to (4,739,005) as of June 1, 2015. During the Trust year the Trust experienced a decrease in its net assets of 438,480.

The Trust had total income of \$83,567,569, including employer contributions of \$83,159,807, interest income of \$51,452, and other income of \$356,310.

Trust expenses were \$84,006,049. These expenses included \$950,521 in operating expenses, \$54,090,319 in benefits paid directly to participants and beneficiaries and \$28,965,209 in other payments to provide benefits.
