LABORERS HEALTH AND WELFARE TRUST FUND FOR NORTHERN CALIFORNIA SUMMARY ANNUAL REPORT 2017

This is a summary of the annual report of the Laborers Health and Welfare Trust Fund for Northern California, 94-1235152, for year ended May 31, 2017. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

SELF-FUNDED BENEFIT INFORMATION

The Board of Trustees of the Laborers Health and Welfare Fund for Northern California has committed itself to pay certain medical, dental, optical and prescription drug claims incurred under the terms of the plan.

INSURANCE INFORMATION

The plan has contracts with Claremont EAP, Delta Dental of California, Kaiser Foundation Health Plan Inc., Newport Dental Plan, and United Healthcare Insurance Company to pay certain behavioral health, medical and dental claims incurred under the terms of the plan. The total premiums paid for the plan year ending May 31, 2017 were \$84,223,899.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$234,254,656 as of May 31, 2017, compared to \$195,142,289 as of June 1, 2016. During the plan year the plan experienced an increase in its net assets of \$39,112,367. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$321,719,466, including employer contributions of \$286,289,813, participant contributions of \$15,459,027, earnings from

investments of \$14,281,722 and other income of \$5,688,904. The plan also received a transfer of assets in the amount of \$2,298,675 as result of a merger.

Plan expenses were \$284,905,774. These expenses included \$16,758,888 in administrative expenses and \$268,146,886 in benefits paid to participants and beneficiaries.

LABORERS ANNUITY PLAN FOR NORTHERN CALIFORNIA SUMMARY ANNUAL REPORT 2017

This is a summary of the annual report for Laborers Annuity Plan for Northern California, 94-6277608, Plan 002, for the year ended May 31, 2017. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a Trust Fund. Plan expenses were \$16,679,837. These expenses included \$1,611,786 in administrative expenses and \$15,068,051 in benefits paid to participants and beneficiaries. A total of 68,136 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$474,554,549 as of May 31, 2017, compared to \$381,351,073 as of June 1, 2016. During the plan year the plan experienced an increase in its net assets of \$93,203,476. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$92,716,823, including employer contributions of \$67,967,487, earnings from investments of \$24,509,820, and other income of \$239,516. During the plan year, the Plan received transfers of assets totaling \$17,166,490.

FUNDING STANDARDS

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

This is a summary of the annual report of the Laborers Vacation/Holiday Trust Fund for Northern California, EIN 94-6092198, for the year ended May 31, 2017. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of Laborers Vacation/Holiday Trust Fund for Northern California has committed itself to pay certain vacation benefit claims incurred under the terms of the plan.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$(5,046,683) as of May 31, 2017, compared to \$(5,177,485) as of June 1, 2016. During the plan year the plan experienced an increase in its net assets of \$130,802. During the plan year, the plan had total income of \$90,572,090, including employer contributions of \$90,514,543, earnings from investments of \$56,117, and other income of \$1,430.

Plan expenses were \$90,441,288. These expenses included \$32,256,968 in administrative expenses (including \$31,178,290 of supplemental dues collected and forwarded to the District Council) and \$58,184,320 in benefits paid to participants and beneficiaries.
