LABORERS HEALTH AND WELFARE PLAN FOR NORTHERN CALIFORNIA SUMMARY ANNUAL REPORT 2022

This is a summary of the annual report of the Laborers Health and Welfare Trust Fund For Northern California, EIN 94-1235152, Plan No. 501, for period June 1, 2021, through May 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of the Laborers Health and Wealth Trust Fund for Northern California has committed itself to pay certain medical, dental, optical, prescription drug, vision, death, and disability benefit claims incurred under the terms of the Plan.

INSURANCE INFORMATION

The plan has contracts with Claremont EAP, Delta Dental of California, Kaiser Foundation Health Plan Inc., Newport Dental Plan, United Healthcare Insurance Company, and Anthem Blue Cross Life and Health Insurance Company to pay certain behavioral health, medical, and dental claims incurred under the terms of the Plan. The total premiums paid for the plan year ending May 31, 2022 were \$142,554,931.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was \$400,639,721 as of May 31, 2022, compared to \$394,165,346 as of June 1, 2021. During the plan year the plan experienced an increase in its net assets of \$6,474,375. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$392,538,041, including employer contributions of \$383,969,299, employee contributions of \$13,556,970, other contributions (ARPA Subsidy) of \$1,496,906, realized losses of \$9,769,923 from the sale of assets, losses from investments of \$16,676,628, and other income of \$19,961,417.

Plan expenses were \$386,063,666. These expenses included \$20,567,742 in administrative expenses, and \$365,495,924 in benefits paid to participants and beneficiaries.

LABORERS ANNUITY PLAN FOR NORTHERN CALIFORNIA SUMMARY ANNUAL REPORT 2022

This is a summary of the annual report for Laborers Annuity Plan for Northern California, 94-6277608, Plan 002, for the year ended May 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a trust fund. Plan expenses were \$54,833,678. These expenses included \$5,080,956 in administrative expenses and \$49,752,722 in benefits paid to participants and beneficiaries. A total of 75,824 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$1,133,454,647 as of May 31, 2022, compared to \$1,062,677,751 as of June 1, 2021. During the plan year the plan experienced an increase in its net assets of \$70,776,896. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$125,610,574, including employer contributions of \$156,469,965, realized losses of \$13,766,136 from the sale of assets, losses from investments of \$17,485,883 and other income of \$392,628.

MINIMUM FUNDING STANDARDS

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.

The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of Laborers Vacation-Holiday Trust Fund for Northern California has committed itself to pay certain vacation benefit claims incurred under the terms of the plan.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the plan, was (\$1,179,615) as of May 31, 2022, compared to (\$3,144,942) as of June 1, 2021. During the plan year the plan experienced an increase in its net assets of \$1,965,327. During the plan year, the plan had total income of \$121,349,417, including employer contributions of \$121,243,345, and earnings from investments of \$106,072.

Plan expenses were \$119,384,090. These expenses included \$36,704,668 in administrative expenses

(including \$35,104,380 of supplemental dues collected and forwarded to the District Council), and \$82,679,422 in benefits paid to participants and beneficiaries.
